Introduction

This supplement dated 9 July 2019 (this "**Supplement**") to each of the base prospectuses listed in the Schedule, each of which comprises a separate base prospectus in respect of Credit Suisse AG ("**CS**") and Credit Suisse International ("**CSi**", and together with CS, the "**Issuers**" and each, an "**Issuer**") (each such base prospectus, as supplemented up to the date of this Supplement, a "**Prospectus**" and, collectively, the "**Prospectuses**"), constitutes a supplement in respect of each Prospectus for the purposes of Article 13 of Chapter 1 of Part II of the Luxembourg Act dated 10 July 2005 on prospectuses for securities as amended by the law of 3 July 2012, the law of 21 December 2012 and the law of 10 May 2016 (the "**Luxembourg Prospectus Law**") and has been approved by the *Commission de Surveillance du Secteur Financier* (the "**CSSF**") in its capacity as competent authority in Luxembourg. Terms defined in the relevant Prospectus shall have the same meanings when used in this Supplement, unless otherwise defined herein.

This Supplement is supplemental to, and should be read in conjunction with, the relevant Prospectus including any other supplements thereto.

Purpose of this Supplement

The purpose of this Supplement is to:

- (a) incorporate by reference Form 6-K Dated 2 July 2019 (as defined below) into each Prospectus in respect of each Issuer; and
- (b) amend information relating to the Executive Board of CS in the section entitled "Credit Suisse AG" in each Prospectus.

Information being supplemented

1. ***Incorporation of information by reference in each Prospectus***

This Supplement incorporates by reference into each Prospectus the Form 6-K of Credit Suisse Group AG (the "**Group**") and CS filed with the United States Securities and Exchange Commission (the "**SEC**") on 2 July 2019 (the "**Form 6-K Dated 2 July 2019**"), which contains a media release announcing changes to the Executive Board of Credit Suisse AG and CS.

2. Amendments to the section entitled "Credit Suisse AG" in each Prospectus

The sub-section entitled "Names and Addresses of Directors and Executives" in the section entitled "Credit Suisse AG" in each Prospectus (in each case, as supplemented up to 23 May 2019), on (i) pages 611 to 629 of the Trigger Redeemable and Phoenix Securities Base Prospectus, (ii) page 697 to 714 of the Put and Call Securities Base Prospectus, (iii) pages 564 to 579 of the Reverse Convertible and Worst of Reverse Convertible Securities Base Prospectus, and (iv) pages 593 to 609 of the Bonus and Participation Securities Base Prospectus, shall be supplemented by deleting the sub-section headed "Executive Board of CS" in its entirety and replacing it with the following:

"Executive Board of CS"

The Executive Board is responsible for the day-to-day operational management of CS, under the leadership of the Chief Executive Officer. Its main duties and responsibilities include:

- (a) establishment of the strategic business plans for CS and its consolidated subsidiaries and for the principal businesses, which are subject to approval by the Board;
- (b) regular review and coordination of significant initiatives, projects and business developments in the divisions and the corporate functions, including important risk management matters;
- (c) regular review of the consolidated and divisional financial performance, including progress on key performance indicators, as well as the consolidated capital and liquidity positions of CS and those of its major subsidiaries;
- (d) appointment and dismissal of senior managers, with the exception of managers from Internal Audit, and the periodic review of senior management talent across CS and talent development programs;
- (e) review and approval of business transactions, including mergers, acquisitions, establishment of joint ventures and establishment of subsidiary companies; and
- (f) approval of key policies for CS.

The composition of the Executive Boards of CS and CSG is identical, with the exception of Mr. Thomas Gottstein, who is a member of the Executive Board of CSG, but not CS. References herein to the "Executive Board" are to both the Executive Board of CS and the Executive Board of CSG, except as otherwise specified.
